### **Information for authors**

All submitted papers (in English or French) are double-blind refereed if accepted by the editors. Papers should be of not more than 7000 words in length (and can be shorter). They should be double spaced, page-numbered and should use a Harvard referencing system. The names and institutional details of the authors should be placed on a separate front sheet, and internal evidence of identity (e.g. self-citations) should be removed. A short abstract (usually less than 150 words) and an equally short ‘points for practitioners’ should be included at the front of the paper.

Authors submitting in English and French should go straight to the SAGETRACK software system (<http://mc.manuscriptcentral.com/iras>.) SAGETRACK includes the necessary information for authors to learn to use it.

Whatever language your paper is submitted in, it will be translated so that it will subsequently appear in all three IRAS editions – English, French and Chinese.
